

## Registration Fee Calculation

### **A. Sale**

<b>Sl. No.</b>	<b>Transaction Minor</b>	<b>Fee calculation</b>
1.	All Minor Transactions cases(Except Exempted ones)	<u>Registration Fee is Calculated Based on Consideration Value:</u> For value up to 100/- fee is Rs.5/- For value more than 100/- but up to 250/- fee is Rs.7/- For value more than 250/- but up to 500/- fee is Rs.12/- For value more than 500/- but up to 1000/- fee is Rs.18/- For every additional 1000/- or part Rs.15/-

### **B. Gift**

Fee calculation applicable is same as in case of Sale Transactions

### **C. Mortgage**

<b>Sl. No.</b>	<b>Transaction Minor</b>	<b>Fee calculation</b>
1.	Mortgage with possession	<u>Registration Fee is Calculated Based on Consideration Value:</u> Fee calculation applicable is same as in case of Sale Transactions
2.	Mortgage without possession	<u>Registration Fee is Calculated Based on Loan Amount:</u> Fee calculation applicable is same as in case of Sale Transactions
3.	Mortgage without possession executed by Govt. servant in f/o of Govt.	Fee is exempted in this case

### **D. Will**

1.	Will Registration	No Stamp Fee is applicable Registration Fee applicable is Rs.30/-

3.	Cancellation of will	Stamp Fee applicable is 30/- Registration Fee applicable is Rs.30/-

3.	Settlement for Marriage(Kabinnama)	Stamp Fee applicable is 6% of Consideration Value Fee calculation applicable is same as in case of Sale Transactions
4.	Settlement for other purpose	Stamp Fee applicable is 5% of Market Value Fee calculation applicable is same as in case of Sale Transactions
5.	Revocation of Settlement	Stamp Fee applicable is 30/- No Registration Fee is applicable
